## 30-mile Ride

2 15-mile loops. Vet checks in camp.

Ride Fee: \$125

## 50-mile Ride

20 mile/loop, 2 15-mile loops. Vet checks in camp.

Ride Fee: \$125

## 70-Mile Mettle Relay

20 mile and 15 mile loop (2 riders, each must ride at least 25 miles) All checks in camp.

Ride Fee: \$250

## 15-mile Ride & Tie

2 runners/riders and 1 horse. Vet checks in camp.

Ride Fee: \$100

## 30-mile Ride & Tie

2 runners/riders and 1 horse. Vet checks in camp.

Ride Fee: \$150

### PRE-REGISTRATION INFO WILL BE POSTED ON THE EDRA WEBSITE

The ride is in the Colville National Forrest and will use recreational trails and roads located on FS lands. Located just outside of Chewelah WA. off of Hi-way 395. This ride overall has very good footing with a few rocky sections. There will be some logging type roads but also scenic trail following beautiful creeks in the forest.

Ride camp is at Calispell Meadows, which is a large grassy meadow in the Colville National Forrest.

### **Directions**

From the South – 395 north to Chewelah WA. At the traffic light continue north .75 mile, turn right on to Sand Canyon Rd. Continue for 8.7 miles until pavement ends. The road changes to FS Road 9521. Stay on it for 8 miles, ridecamp is on the right. (Calispell Meadows).

From the North – From Colville, WA travel south 19.1 miles. Turn left onto Kramer Rd. go 1 mile to "T". Left turn onto Sand Canyon Rd. Continue for 7.5 miles until pavement ends. The road changes to FS Road 9521. Stay on it for 8 miles, ridecamp is on the right. (Calispell Meadows).
