Spin back the hands of a clock and I remember sharing the trail with Mary Nunn and Anna Sampson – from the mid1980s through to the early 20teens. They weren't just avid participants, they were accomplished horsewomen, caring parents and grandparents, best of friends and helpful colleagues in this strange little sport of ours. At some point early on, they also made the decision to become devoted volunteers.



Mary and Anna were ardent champions of our sport and the people in it. Irrespective of where one's

personal trails might have led, Anna and Mary were there to encourage, support, welcome and make distance riding possible for many. Without their taking on ride manager, ride secretary, trail marking, water hauling, timer, pulser, and other associated volunteer efforts, many a ride could likely have gone by the wayside. They helped at both EDRA and AERC events and it is because of who they were and what they did that we all seem to come together to remember and honor their legacy.



As many observed, Anna and Mary supported youth – sometimes by finding or training the "right" kid's horse, sometimes giving a child a home with security and love. Their advocacy of youth was unlimited. Their offerings to children unyielding.

With their passing and this background in mind, and as the administrator of the Anna & Mary Memorial Youth Fund (The Fund), I am providing a mid-year report on the status of The Fund and wish to publicly recognize those who have been instrumental in our collective success. The Fund supports ride managers, youth participants and their families, and it also ensures Anna's and Mary's legacy is alive and well – which means the world to those of us who were mentored by these women.

The list of those donating to the cause is long and there are a wide variety of contributors:

- Ride managers who provide a "Kids Ride Free" ride entry pricing policy. This policy has been adopted by many rides within the PNER footprint and is a huge benefit to any family with a child who rides endurance.
 - When ride managers offer this level of a discount, they can choose to be reimbursed for half the amount of a regular ride entry from The Fund. If they do not request reimbursement, they are making a virtual donation and are ensuring monies will be available to other ride managers. - Then there are ride managers who donate proceeds from their ride directly to The Fund
 Trout Lake 100 and Anna & Mary Memorial rides have provided this incredible support for several years and both committed to take this action again in 2021.

¹ Ride managers who do not request reimbursement for youth ride entry fees from The Fund – this is the equivalent of making a donation, but was not tracked in detail until 2021.

² The YTD 2021 eligible payout amount reflects amounts that would have been paid out except that the ride manager chose not to access The Fund. This figure is required in order to balance with the ride manager's donation reported in the corresponding section.

³ Through July 3, 2021 there have been 18 ride dates and a total of 86 eligible youth participants. We have experienced an average of 5 youth riders for every day of rides. Although the Canadian ride schedule is still in flux, the PNER footprint is on track to hold 50+ days of riding in 2021. (38 AERC, 7 EDRA and 7 ERABC.) The remaining estimated payments listed above assumes an average of 5 youth per ride day for the remaining potential rides and an average payment of \$55 per eligible youth.
